



# Alternative Loan Lender Form Fall 2018/Spring 2019/Maymester 2019

- STEP 1:** Request the loan from the lender and get it approved. OFA will certify your loan once you have completed the loan approval process.
- STEP 2:** Turn in this completed form to OFA. **The certification process can take up to three weeks.**
- STEP 3:** Once certified, you will be able to view your alternative loan on CASH.
- STEP 4:** The lender sends funds to UT. OFA will disburse your funds as soon as possible. Disbursement dates are set using federal and state regulations and cannot be changed. **Funds are disbursed when the lender sends the funds. It takes two to four weeks after certification for funds to arrive at UT.**
